The Company will pay a final dividend of 2017 in cash of RMB0.27 per Share (inclusive of applicable tax) (the "**Final Dividend**") to holders of A Shares (the "**A Shareholders**") and holders of H Shares (the "**H Shareholders**") whose names appear on the register of members of the Company at the close of business on the respective record dates for the A Shareholders and H Shareholders. For H Shares, the Company will pay the Final Dividend to the H Shareholders whose names appear on the register of members of H Shares of the Company at the close of business on H Shares of the Company at the close of business on 19 June 2018 (Tuesday) as the record date for H Shares (the "**Record Date**"). According to the articles of association of the Company, dividends payable to the A Shareholders shall be paid in Renminbi while dividends payable to the H Shareholders shall be paid in Hong Kong dollars and the following formula shall apply for the purpose of calculating the Hong Kong dollar equivalent of the amount of Final Dividend payable per H Share:

The median exchange rate for Hong Kong dollar to Renminbi as announced by the People's Bank of China on 11 June 2018, which is the first business day immediately following the day of the AGM at which the Final Dividend is declared, is HK\$1.00 to RMB0.81648. WITHHOLDING AND PAYMENT OF CORPORATE INCOME TAX FOR NON-RESIDENT ENTERPRISE SHAREHOLDERS

According to the Law on Corporate Income Tax of the People's Republic of China (《中華人民 共和國企業所得税法》) and the relevant implementing rules which came into effect on 1 January 2008, the Company is required to withhold and pay corporate income tax at the rate of 10% before distributing dividends to non-resident enterprise shareholders whose names appear on the register of members of H Shares of the Company. Any H Shares registered in the name of non-individual H Shareholders, including HKSCC Nominees Limited, other nominees, trustees or other groups and organizations will be treated as being held by non-resident enterprise shareholders and therefore will be subject to the withholding and payment of the corporate income tax. Should any H Shareholder wishes to change its shareholder status, please consult your agent or trust institution over the relevant procedure. The Company will withhold payment of the corporate income tax strictly in accordance with the relevant laws or requirements of the relevant governmental departments and strictly based on what has been registered on the Company's register of members of H Shares on the Record Date.

WITHHOLDING AND PAYMENT OF INDIVIDUAL INCOME TAX FOR INDIVIDUAL FOREIGN SHAREHOLDERS

According to the regulation promulgated by the State General Administration of Taxation of the People's Republic of China (Guo Shui Han [2011] No.348), the Company is required to withhold and pay the individual income tax for its individual H Shareholders (the "Individual H Shareholders") and the Individual H Shareholders are entitled to the relevant tax preferential treatments according to the tax agreements between those countries where the Individual H Shareholders are residents and China and the provisions in respect of tax arrangements between the mainland China and Hong Kong (Macau). The Company would withhold and pay the individual income tax at the tax rates of 10% on behalf of the Individual H Shareholders who are Hong Kong residents, Macau residents or residents of those countries having agreements with China for personal income tax rates in respect of dividend of 10%. For Individual H Shareholders who are residents of those countries having agreements with China for personal income tax rates in respect of dividend of lower than 10%, the Company would make applications on their behalf to seek entitlement of the relevant agreed preferential treatments. For Individual H Shareholders who are residents of those countries having agreements with China for personal income tax rates in respect of dividend of higher than 10% but lower than 20%, the Company would withhold the individual income tax at the agreed-upon effective tax rate. For Individual H Shareholders who are residents of those countries without any taxation agreements with China or having agreements with China for personal income tax in respect of dividend of 20% and other situations, the Company would withhold the individual income tax at a tax rate of 20%.

The Company will determine the country of domicile of the Individual H Shareholders based on the registered address as recorded in the register of members of the Company (the "**Registered Address**") on the Record Date and will accordingly withhold and pay the individual income tax. If the country of domicile of the Individual H Shareholder is not the same as the Registered Address, the Individual H Shareholder shall notify the share registrar of the Company's H Shares and provide relevant supporting documents on or before 4:30 p.m., 13 June 2018 (Wednesday) (Computershare Hong Kong Investor Services Limited, address: Shops 1712 – 1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong). If the Individual H Shareholders do not provide the relevant supporting documents to the share registrar of the Company's H Shares within the time period stated above, the Company will determine the country of domicile of the Individual H Shareholders based on the recorded Registered Address on the Record Date.

The Company will not entertain any claims arising from and assume no liability whatsoever in respect of any delay in, or inaccurate determination of, the status of the Shareholders or any disputes over the withholding and payment of tax.

In order to determine the list of H Shareholders who are entitled to receive the Final Dividend, the Company's register of members of H Shares will be closed from 14 June 2018 (Thursday) to 19 June 2018 (Tuesday) (both days inclusive) during which period no transfer of H Shares will be registered. In order to qualify for the Final Dividend, H Shareholders whose transfers have not been registered must lodge all transfer documents together with the relevant share certificates at the Company's share registrar for H Shares, Computershare Hong Kong Investor Services Limited at Shops 1712 - 1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong at or before 4:30 p.m. on 13 June 2018 (Wednesday).

The Company appoints Industrial and Commercial Bank of China (Asia) Limited as the receiving agent in Hong Kong (the "**Receiving Agent**") and will pay to such Receiving Agent the Final Dividend declared for payment to H Shareholders. The Final Dividend will be paid on 20 July 2018 which will be despatched to H Shareholders who are entitled to receive such dividend by cheques by ordinary post and at their own risk.

PAYMENT OF THE FINAL DIVIDEND FOR INVESTORS INVESTING IN H SHARES OF THE COMPANY THROUGH SHENZHEN-HONG KONG STOCK CONNECT

For investors (including enterprises and individuals) investing in the H Shares of the Company listed on the Hong Kong Stock Exchange through the Shenzhen Stock Exchange, the Shenzhen Branch of China Securities Depository and Clearing Corporation Limited, which is expected to be the nominee of the holders of H Shares through Shenzhen-Hong Kong Stock Connect, will receive the Final Dividend distributed by the Company and distribute the Final Dividend to the relevant investors of H Shares through Shenzhen-Hong Kong Stock Connect through its depositary and clearing system.
